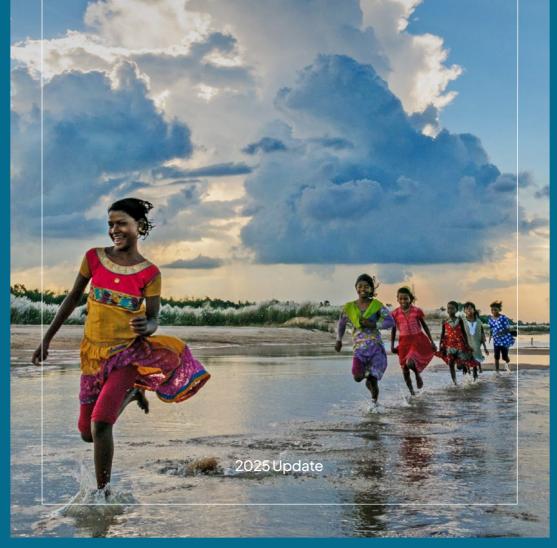

#### **Preface**

We are at a critical juncture. The well-being of our planet, ecosystems, animals, and the people that rely on it are threatened by the intersecting and compounding climate and biodiversity crisis, as well as the rapid advancement of land degradation and desertification. Despite these crises, Indigenous Peoples have been standing up and proposing an alternative way to relate to the natural world, a way grounded in the reestablishment of a reciprocal and respectful relationship with the natural world. This voice and the leadership of Indigenous Peoples in stewarding nature has been increasingly recognized within spaces such as the UN Framework Convention on Climate Change (UNFCCC). The work in this compilation, prepared in collaboration between the Centre for Environmental Law (CIEL) and the International Indigenous Peoples Forum on Climate Change (IIPFCC), of capturing this growing recognition provides a critical documentation of the references to the rights of Indigenous Peoples, our knowledge systems, and our full and effective participation in the UNFCCC process. These elements are the foundation of rights-based climate action that both uplifts Indigenous-led solutions while also preventing false solutions that presume the continuation of technologies and markets that have been built on the exploitation and dispossession of Indigenous Peoples.

Over the course of the last two years, 2023 and 2024, all the UN mechanisms with a mandate dedicated to Indigenous Peoples have prepared detailed analyses of the threats and opportunities facing Indigenous Peoples in climate finance, green transitions, and self-determination. These analyses affirm a vision of climate and environmental justice that places Indigenous Peoples at the heart of global efforts to address the multifaceted climate and biodiversity crises. For instance, the Special Rapporteur's annual thematic report to the Human Rights Council on the topic of green finance and the rights of Indigenous Peoples concludes that while the "shift to green energy is necessary and urgent, and if done using a human rights-based approach, can be a source of opportunity for Indigenous Peoples ... the financing of green energy projects must not contribute to the human rights violations that currently plague extractive and other fossil-fuel-related projects". the outcome of an Expert Group Meeting on "Indigenous Peoples in a Greening Economy" were presented at the 24th Session of the UN Permanent Forum on Indigenous Issues. <sup>ii</sup> The UN Expert Mechanism on the Rights of Indigenous Peoples recently noted that "A just transition to sustainable economies, societies and energy systems is urgently needed and must be managed carefully to avoid infringing on Indigenous Peoples' human rights. <sup>iii</sup> In addition to the work of these mechanisms, significant work has been produced in the context of Indigenous-led initiatives, such as the Indigenous Summit on Just Transition: Indigenous Peoples' Perspectives, Knowledge, and Lived Experience. The Summit, hosted from October 8 to 10, 2024, established a set of Principles and Protocols for Just Transition from the perspective of all seven sociocultural regions to underscore recognition of and respect for Indigenous Peoples' self-determination in the context of critical minerals. <sup>iv</sup>

Ultimately, those advancing the messages of over 450 million Indigenous Peoples worldwide have been consistent: substance and action toward addressing global climate, biodiversity, and desertification cannot remain premised on the same colonial state of mind. The force of colonialism has directly jeopardized the integrity of the planet and the violation of Indigenous Peoples' human rights, including our diverse livelihoods, lands and territories, and our intricate knowledge systems. Yet, we continue to stand at the front lines of ecosystem stewardship, grounded by a millennium of living in balance with the natural world. For these and many other reasons, Indigenous Peoples must not continue to be excluded from exercising self-determination through our direct participation in decision-making processes regarding our ecosystems, environment, management, and finance resources dedicated to those interrelated issues. The UN Secretary-General's Panel on Critical Energy Transition Minerals<sup>v</sup> reflected this rights-based approach, providing space for the input of Indigenous Peoples and highlighting the importance of equitable mineral development for countries and communities.

As affirmed by the UN Declaration on the Rights of Indigenous Peoples, the imposition of green energy projects, conservation efforts, carbon markets, and so-called land "restoration" projects upon Indigenous Peoples and their Lands and Waters without their Free, Prior, and Informed Consent, has reproduced gross human rights violations, including alienation, dispossession, eviction, local conflicts, and even the militarization of our lands and territories. VI The injustices and inequities must end. States, international organizations, financial institutions, and private actors must acknowledge and end their contributions to such a destructive course. Rather, we call upon the world community to take the hand that we extend, to work in true partnership with Indigenous Peoples, and to ensure the full respect for and recognition of our collective human rights as distinct nations, peoples, and communities.

Looking ahead, we remain hopeful. The growing recognition of the rights and knowledge systems of Indigenous Peoples, captured within this report, as well as the growing participation of Indigenous Peoples within the global climate agenda, is a step in the right direction. Initiatives that provide direct financing to Indigenous-led conservation efforts, renewable energy, and just transition projects, as well as land restoration initiatives, are setting important precedents. The Permanent Forum called for enhanced and equitable access to financial mechanisms like the Green Climate Fund and the Global Biodiversity Framework Fund, ensuring that Indigenous Peoples can participate fully and meaningfully in these opportunities.

There is, however, much work to be done. We call on UN Member States and entities involved in climate action to engage in genuine dialogue, ethical and equitable engagement, and partnership with Indigenous Peoples. The rights of Indigenous Peoples are not obstacles to progress; rather, they are essential components of a just, equitable, and resilient future. It is the start of a path toward decolonization. We can create a transformation. As humankind, we must recognize a moment of responsibility: let us commit to a future where Indigenous Peoples lead, where our self-determination and knowledge are respected, and where our rights are protected and — perhaps more importantly — exercised.

## Part 1 Introduction

As the recognition of Indigenous Peoples and their knowledge systems' unique role in climate action increases, so does the frequency and severity of extreme climate events. The last several years have been rapidly warming, with 2024 being the hottest year on record. Indigenous Peoples and the ecosystems they rely upon have been severely affected by climate impacts around the globe, including, but not limited to, wildfires and deadly heatwaves across continental North America, Europe, and India, which have resulted in over 700 deaths. Additionally, severe flooding has affected Brazil, China, Spain, and Central Europe, ii contributing to 2024 being the year with the most displacements as a result of climate-related events since 2008. These impacts, while catastrophic, have been foretold by Indigenous Peoples, as Knowledge Holders have been sounding the alarm bell, urgently voicing concerns to warn of the impacts of climate change. These concerns were raised during the founding of the original Rio Declaration on Environment and Development, where, in 1992, Parties acknowledged the unique contributions of Indigenous Peoples, "Indigenous people and their communities ... have a vital role in environmental management and development because of their knowledge and traditional practices." Fast forward to today, the main outcome of the 28th Conference of the Parties (COP 28) was the Global Stocktake (GST), where Parties were called upon "to meaningfully engage Indigenous Peoples" and local communities in their climate policies and action." Clearly, Indigenous Peoples play a unique role in taking urgent and transformative action against the intersecting climate, biodiversity, and health crises.

Despite these growing acknowledgments, the global trajectory of emissions reductions is trending in the wrong direction. The annual Nationally Determined Contributions (NDCs) Synthesis Report produced by the UNFCCC Secretariat confirmed that current NDCs will increase emissions less (by 8.6 percent instead of 10.6 percent) by 2030. However, the UN Intergovernmental Panel on Climate Change (IPCC) warns of the imperative of reducing global emissions by 43 percent by 2030, compared to 2019 levels. In both circumstances, these reductions do not align with the advocacy of Indigenous Peoples.

In Paris, representatives of Indigenous Peoples believed that the proposed 2°C goal would increase poverty and hunger among Indigenous Peoples, and thus urged "Parties in Paris to commit to a maximum temperature increase of 1.5°C and called for a review to determine whether the target should be further lowered to a maximum temperature increase of 1.0°C. Although these advocacy efforts were not successful, Indigenous Peoples were successful in getting rights-based language included in the Paris Agreement preamble, "Parties should, when taking action to address climate change, respect, promote and consider their respective obligations on human rights, the right to health, the rights of Indigenous Peoples ..." in and called for a review to determine whether the target should be further lowered to a maximum temperature increase of 1.0°C.

A rights-based approach, including commitments to uphold the minimum standards contained in the United Nations Declaration on the Rights of Indigenous Peoples, is essential to climate solutions that are grounded in equity, justice, and the self-determination of Indigenous Peoples. Capturing this leadership is essential to understand the true contribution that Indigenous Peoples have brought to the conversation with the United Nations Framework Convention on Climate Change (UNFCCC) and the broader climate discourse. We are pleased to continue the partnership with the Centre for International Environmental Law (CIEL) on this important compilation, listing all references to Indigenous Peoples and traditional knowledge contained in political documents adopted by the Parties to the UNFCCC through the Conference of the Parties (COP) and its subsidiary bodies. These references, mandates, and commitments constitute a floor, as many national and international legal frameworks extend beyond the references adopted by the UNFCCC. The rules, principles, and norms established under the climate agreements complement other norms adopted by governments on this issue.

This work builds on the previous editions, prepared in 2019 and 2021, following a similar structure to the previous publications. This document first recalls the relevant provisions of the UN Declaration of the Rights of Indigenous Peoples (Part 2). The compilation then provides the citations for all relevant references contained in the agreements, decisions, and conclusions adopted under the UNFCCC (Part 3). This compilation first cites relevant provisions of the Paris Agreement (Part 3.1). It then lists the mandates related to the Local Communities and Indigenous Peoples Platform (Part 3.2) and compiles by thematic policy area all other references to Indigenous Peoples and traditional knowledge (Part 3.3).

Since the publication of the last edition of this compilation, references to Indigenous Peoples and traditional knowledge in formal COP outcomes have increased significantly. Each COP held since COP26 has adopted between 15 and 21 decisions containing explicit references to Indigenous Peoples and/or traditional knowledge, across a wide range of COP and CMA agenda items. This is more than double the rate of references recorded at any previous COP. Many of these decisions reaffirm the importance of Indigenous Peoples' participation in decision-making or the need to respect their rights in implementing climate policies, while others include specific mandates for action.

## Part 2: International Legal Framework

#### UN Declaration on the Rights of Indigenous Peoples

The General Assembly,

Guided by the purposes and principles of the Charter of the United Nations, and good faith in the fulfilment of the obligations assumed by States in accordance with the Charter.

Affirming that **indigenous peoples** are equal to all other peoples, while recognizing the right of all peoples to be different, to consider themselves different, and to be respected as such,

Affirming also that all peoples contribute to the diversity and richness of civilizations and cultures, which constitute the common heritage of humankind,

Affirming further that all doctrines, policies and practices based on or advocating superiority of peoples or individuals on the basis of national origin or racial, religious, ethnic or cultural differences are racist, scientifically false, legally invalid, morally condemnable and socially unjust,

Reaffirming that **indigenous peoples**, in the exercise of their rights, should be free from discrimination of any kind,

Concerned that **indigenous peoples** have suffered from historic injustices as a result of, inter alia, their colonization and dispossession of their lands, territories and resources, thus preventing them from exercising, in particular, their right to development in accordance with their own needs and interests.

Recognizing the urgent need to respect and promote the inherent **rights** of indigenous peoples which derive from their political, economic and social structures and from their cultures, spiritual traditions, histories and philosophies, especially their rights to their lands, territories and resources.

Recognizing also the urgent need to respect and promote the **rights of indigenous peoples** affirmed in treaties, agreements and other constructive arrangements with States,

Welcoming the fact that **indigenous peoples** are organizing themselves for political, economic, social and cultural enhancement and in order to bring to an end all forms of discrimination and oppression wherever they occur,

Convinced that control by **indigenous peoples** over developments affecting them and their lands, territories and resources will enable them to maintain and strengthen their institutions, cultures and traditions, and to promote their development in accordance with their aspirations and needs.

Recognizing that respect for **indigenous knowledge**, cultures and traditional practices contributes to sustainable and equitable development and proper management of the environment,

Emphasizing the contribution of the demilitarization of the lands and territories of **indigenous peoples** to peace, economic and social progress and development, understanding and friendly relations among nations and peoples of the world,

Recognizing in particular the right of indigenous families and communities to retain shared responsibility for the upbringing, training, education and well-being of their children, consistent with the rights of the child.

Considering that the rights affirmed in treaties, agreements and other constructive arrangements between States and **indigenous peoples** are, in some situations, matters of international concern, interest, responsibility and character,

Considering also that treaties, agreements and other constructive arrangements, and the relationship they represent, are the basis for a strengthened partnership between **indigenous peoples** and States,

Acknowledging that the Charter of the United Nations, the International Covenant on Economic, Social and Cultural Rights and the International Covenant on Civil and Political Rights, ¹ as well as the Vienna Declaration and Programme of Action, ² affirm the fundamental importance of the right to self-determination of all peoples, by virtue of which they freely determine their political status and freely pursue their economic, social and cultural development,

Bearing in mind that nothing in this Declaration may be used to deny any peoples their right to self-determination, exercised in conformity with international law.

Convinced that the recognition of the **rights of indigenous peoples** in this Declaration will enhance harmonious and cooperative relations between the State and **indigenous peoples**, based on principles of justice, democracy, respect for human rights, non-discrimination and good faith,

Encouraging States to comply with and effectively implement all their obligations as they apply to **indigenous peoples** under international instruments, in particular those related to human rights, in consultation and cooperation with the peoples concerned,

Emphasizing that the United Nations has an important and continuing role to play in promoting and protecting the **rights of indigenous peoples**,

Believing that this Declaration is a further important step forward for the recognition, promotion and protection of the rights and freedoms of **indigenous peoples** and in the development of relevant activities of the United Nations system in this field,

Recognizing and reaffirming that indigenous individuals are entitled without discrimination to all human rights recognized in international law, and that **indigenous peoples** possess collective rights which are indispensable for their existence, well-being and integral development as peoples,

Recognizing that the situation of **indigenous peoples** varies from region to region and from country to country and that the significance of national and regional particularities and various historical and cultural backgrounds should be taken into consideration,

Solemnly proclaims the following United Nations Declaration on the **Rights of Indigenous Peoples** as a standard of achievement to be pursued in a spirit of partnership and mutual respect:

#### Article 1

**Indigenous peoples** have the right to the full enjoyment, as a collective or as individuals, of all human rights and fundamental freedoms as recognized in the Charter of the United Nations, the Universal Declaration of Human Rights<sup>3</sup> and international human rights law.

#### Article 2

**Indigenous peoples** and individuals are free and equal to all other peoples and individuals and have the right to be free from any kind of discrimination, in the exercise of their rights, in particular that based on their indigenous origin or identity.

#### Article 3

**Indigenous peoples** have the right to self-determination. By virtue of that right they freely determine their political status and freely pursue their economic, social and cultural development.

#### Article 4

**Indigenous peoples**, in exercising their right to self-determination, have the right to autonomy or self-government in matters relating to their internal and local affairs, as well as ways and means for financing their autonomous functions.

#### Article 5

**Indigenous peoples** have the right to maintain and strengthen their distinct political, legal, economic, social and cultural institutions, while retaining their right to participate fully, if they so choose, in the political, economic, social and cultural life of the State.

#### Article 6

Every indigenous individual has the right to a nationality.

- 1. Indigenous individuals have the rights to life, physical and mental integrity, liberty and security of person.
- 2. **Indigenous peoples** have the collective right to live in freedom, peace and security as distinct peoples and shall not be subjected to any act of genocide or any other act of violence, including forcibly removing children of the group to another group.

#### Article 8

- 1. **Indigenous peoples** and individuals have the right not to be subjected to forced assimilation or destruction of their culture.
- 2. States shall provide effective mechanisms for prevention of, and redress for:
  - (a) Any action which has the aim or effect of depriving them of their integrity as distinct peoples, or of their cultural values or ethnic identities;
  - (b) Any action which has the aim or effect of dispossessing them of their lands, territories or resources;
  - (c) Any form of forced population transfer which has the aim or effect of violating or undermining any of their rights;
  - (d) Any form of forced assimilation or integration;
  - (e) Any form of propaganda designed to promote or incite racial or ethnic discrimination directed against them.

#### Article 9

**Indigenous peoples** and individuals have the right to belong to an indigenous community or nation, in accordance with the traditions and customs of the community or nation concerned. No discrimination of any kind may arise from the exercise of such a right.

#### Article 10

**Indigenous peoples** shall not be forcibly removed from their lands or territories. No relocation shall take place without the free, prior and informed consent of the **indigenous peoples** concerned and after agreement on just and fair compensation and, where possible, with the option of return.

#### Article 11

1. **Indigenous peoples** have the right to practise and revitalize their cultural traditions and customs. This includes the right to maintain, protect and develop the past, present and future manifestations of their cultures, such as archaeological and historical sites, artefacts, designs, ceremonies, technologies and visual and performing arts and literature.

2. States shall provide redress through effective mechanisms, which may include restitution, developed in conjunction with **indigenous peoples**, with respect to their cultural, intellectual, religious and spiritual property taken without their free, prior and informed consent or in violation of their laws, traditions and customs.

#### Article 12

- 1. **Indigenous peoples** have the right to manifest, practise, develop and teach their spiritual and religious traditions, customs and ceremonies; the right to maintain, protect, and have access in privacy to their religious and cultural sites; the right to the use and control of their ceremonial objects; and the right to the repatriation of their human remains.
- 2. States shall seek to enable the access and/or repatriation of ceremonial objects and human remains in their possession through fair, transparent and effective mechanisms developed in conjunction with **indigenous peoples** concerned.

#### Article 13

- 1. **Indigenous peoples** have the right to revitalize, use, develop and transmit to future generations their histories, languages, oral traditions, philosophies, writing systems and literatures, and to designate and retain their own names for communities, places and persons.
- 2. States shall take effective measures to ensure that this right is protected and also to ensure that **indigenous peoples** can understand and be understood in political, legal and administrative proceedings, where necessary through the provision of interpretation or by other appropriate means.

- 1. **Indigenous peoples** have the right to establish and control their educational systems and institutions providing education in their own languages, in a manner appropriate to their cultural methods of teaching and learning.
- 2. Indigenous individuals, particularly children, have the right to all levels and forms of education of the State without discrimination.

3. States shall, in conjunction with **indigenous peoples**, take effective measures, in order for indigenous individuals, particularly children, including those living outside their communities, to have access, when possible, to an education in their own culture and provided in their own language.

#### Article 15

- 1. **Indigenous peoples** have the right to the dignity and diversity of their cultures, traditions, histories and aspirations which shall be appropriately reflected in education and public information.
- 2. States shall take effective measures, in consultation and cooperation with the **indigenous peoples** concerned, to combat prejudice and eliminate discrimination and to promote tolerance, understanding and good relations among **indigenous peoples** and all other segments of society.

#### Article 16

- 1. **Indigenous peoples** have the right to establish their own media in their own languages and to have access to all forms of non-indigenous media without discrimination.
- 2. States shall take effective measures to ensure that State-owned media duly reflect indigenous cultural diversity. States, without prejudice to ensuring full freedom of expression, should encourage privately owned media to adequately reflect indigenous cultural diversity.

- 1. Indigenous individuals and peoples have the right to enjoy fully all rights established under applicable international and domestic labour law.
- 2. States shall in consultation and cooperation with **indigenous peoples** take specific measures to protect indigenous children from economic exploitation and from performing any work that is likely to be hazardous or to interfere with the child's education, or to be harmful to the child's health or physical, mental, spiritual, moral or social development, taking into account their special vulnerability and the importance of education for their empowerment.
- 3. Indigenous individuals have the right not to be subjected to any discriminatory conditions of labour and, inter alia, employment or salary.

#### Article 18

**Indigenous peoples** have the right to participate in decision-making in matters which would affect their rights, through representatives chosen by themselves in accordance with their own procedures, as well as to maintain and develop their own indigenous decision-making institutions.

#### Article 19

States shall consult and cooperate in good faith with the **indigenous peoples** concerned through their own representative institutions in order to obtain their free, prior and informed consent before adopting and implementing legislative or administrative measures that may affect them.

#### Article 20

- 1. **Indigenous peoples** have the right to maintain and develop their political, economic and social systems or institutions, to be secure in the enjoyment of their own means of subsistence and development, and to engage freely in all their traditional and other economic activities.
- 2. **Indigenous peoples** deprived of their means of subsistence and development are entitled to just and fair redress.

#### Article 21

- 1. **Indigenous peoples** have the right, without discrimination, to the improvement of their economic and social conditions, including, inter alia, in the areas of education, employment, vocational training and retraining, housing, sanitation, health and social security.
- 2. States shall take effective measures and, where appropriate, special measures to ensure continuing improvement of their economic and social conditions. Particular attention shall be paid to the rights and special needs of indigenous elders, women, youth, children and persons with disabilities.

#### Article 22

1. Particular attention shall be paid to the rights and special needs of indigenous elders, women, youth, children and persons with disabilities in the implementation of this Declaration.

2. States shall take measures, in conjunction with **indigenous peoples**, to ensure that indigenous women and children enjoy the full protection and guarantees against all forms of violence and discrimination.

#### Article 23

**Indigenous peoples** have the right to determine and develop priorities and strategies for exercising their right to development. In particular, **indigenous peoples** have the right to be actively involved in developing and determining health, housing and other economic and social programmes affecting them and, as far as possible, to administer such programmes through their own institutions.

#### Article 24

- 1. **Indigenous peoples** have the right to their traditional medicines and to maintain their health practices, including the conservation of their vital medicinal plants, animals and minerals. Indigenous individuals also have the right to access, without any discrimination, to all social and health services.
- 2. Indigenous individuals have an equal right to the enjoyment of the highest attainable standard of physical and mental health. States shall take the necessary steps with a view to achieving progressively the full realization of this right.

#### Article 25

**Indigenous peoples** have the right to maintain and strengthen their distinctive spiritual relationship with their traditionally owned or otherwise occupied and used lands, territories, waters and coastal seas and other resources and to uphold their responsibilities to future generations in this regard.

- 1. **Indigenous peoples** have the right to the lands, territories and resources which they have traditionally owned, occupied or otherwise used or acquired.
- 2. **Indigenous peoples** have the right to own, use, develop and control the lands, territories and resources that they possess by reason of traditional ownership or other traditional occupation or use, as well as those which they have otherwise acquired.

3. States shall give legal recognition and protection to these lands, territories and resources. Such recognition shall be conducted with due respect to the customs, traditions and land tenure systems of the **indigenous peoples** concerned.

#### Article 27

States shall establish and implement, in conjunction with **indigenous peoples** concerned, a fair, independent, impartial, open and transparent process, giving due recognition to **indigenous peoples**' laws, traditions, customs and land tenure systems, to recognize and adjudicate the **rights of indigenous peoples** pertaining to their lands, territories and resources, including those which were traditionally owned or otherwise occupied or used. **Indigenous peoples** shall have the right to participate in this process.

#### Article 28

- 1. **Indigenous peoples** have the right to redress, by means that can include restitution or, when this is not possible, just, fair and equitable compensation, for the lands, territories and resources which they have traditionally owned or otherwise occupied or used, and which have been confiscated, taken, occupied, used or damaged without their free, prior and informed consent.
- 2. Unless otherwise freely agreed upon by the peoples concerned, compensation shall take the form of lands, territories and resources equal in quality, size and legal status or of monetary compensation or other appropriate redress.

- 1. **Indigenous peoples** have the right to the conservation and protection of the environment and the productive capacity of their lands or territories and resources. States shall establish and implement assistance programmes for **indigenous peoples** for such conservation and protection, without discrimination.
- 2. States shall take effective measures to ensure that no storage or disposal of hazardous materials shall take place in the lands or territories of **indigenous peoples** without their free, prior and informed consent.
- 3. States shall also take effective measures to ensure, as needed, that programmes for monitoring, maintaining and restoring the health of **indigenous peoples**, as developed and implemented by the peoples affected by such materials, are duly implemented.

#### Article 30

- 1. Military activities shall not take place in the lands or territories of **indigenous peoples**, unless justified by a relevant public interest or otherwise freely agreed with or requested by the **indigenous peoples** concerned.
- 2. States shall undertake effective consultations with the **indigenous peoples** concerned, through appropriate procedures and in particular through their representative institutions, prior to using their lands or territories for military activities.

#### Article 31

- 1. Indigenous peoples have the right to maintain, control, protect and develop their cultural heritage, traditional knowledge and traditional cultural expressions, as well as the manifestations of their sciences, technologies and cultures, including human and genetic resources, seeds, medicines, knowledge of the properties of fauna and flora, oral traditions, literatures, designs, sports and traditional games and visual and performing arts. They also have the right to maintain, control, protect and develop their intellectual property over such cultural heritage, traditional knowledge, and traditional cultural expressions.
- 2. In conjunction with **indigenous peoples**, States shall take effective measures to recognize and protect the exercise of these rights.

- 1. **Indigenous peoples** have the right to determine and develop priorities and strategies for the development or use of their lands or territories and other resources.
- 2. States shall consult and cooperate in good faith with the **indigenous peoples** concerned through their own representative institutions in order to obtain their free and informed consent prior to the approval of any project affecting their lands or territories and other resources, particularly in connection with the development, utilization or exploitation of mineral, water or other resources.
- 3. States shall provide effective mechanisms for just and fair redress for any such activities, and appropriate measures shall be taken to mitigate adverse environmental, economic, social, cultural or spiritual impact.

#### Article 33

- 1. **Indigenous peoples** have the right to determine their own identity or membership in accordance with their customs and traditions. This does not impair the right of indigenous individuals to obtain citizenship of the States in which they live.
- 2. **Indigenous peoples** have the right to determine the structures and to select the membership of their institutions in accordance with their own procedures.

Article 34

**Indigenous peoples** have the right to promote, develop and maintain their institutional structures and their distinctive customs, spirituality, traditions, procedures, practices and, in the cases where they exist, juridical systems or customs, in accordance with international human rights standards.

Article 35

**Indigenous peoples** have the right to determine the responsibilities of individuals to their communities.

Article 36

- 1. **Indigenous peoples**, in particular those divided by international borders, have the right to maintain and develop contacts, relations and cooperation, including activities for spiritual, cultural, political, economic and social purposes, with their own members as well as other peoples across borders.
- 2. States, in consultation and cooperation with **indigenous peoples**, shall take effective measures to facilitate the exercise and ensure the implementation of this right.

Article 37

1. **Indigenous peoples** have the right to the recognition, observance and enforcement of treaties, agreements and other constructive arrangements concluded with States or their successors and to have States honour and respect such treaties, agreements and other constructive arrangements.



2. Nothing in this Declaration may be interpreted as diminishing or eliminating the **rights of indigenous peoples** contained in treaties, agreements and other constructive arrangements.

#### Article 38

States in consultation and cooperation with **indigenous peoples**, shall take the appropriate measures, including legislative measures, to achieve the ends of this Declaration.

#### Article 39

**Indigenous peoples** have the right to have access to financial and technical assistance from States and through international cooperation, for the enjoyment of the rights contained in this Declaration.

#### Article 40

**Indigenous peoples** have the right to access to and prompt decision through just and fair procedures for the resolution of conflicts and disputes with States or other parties, as well as to effective remedies for all infringements of their individual and collective rights. Such a decision shall give due consideration to the customs, traditions, rules and legal systems of the **indigenous peoples** concerned and international human rights.

#### Article 41

The organs and specialized agencies of the United Nations system and other intergovernmental organizations shall contribute to the full realization of the provisions of this Declaration through the mobilization, inter alia, of financial cooperation and technical assistance. Ways and means of ensuring participation of **indigenous peoples** on issues affecting them shall be established.

#### Article 42

The United Nations, its bodies, including the Permanent Forum on Indigenous Issues, and specialized agencies, including at the country level, and States shall promote respect for and full application of the provisions of this Declaration and follow up the effectiveness of this Declaration.



#### Article 43

The rights recognized herein constitute the minimum standards for the survival, dignity and well-being of the **indigenous peoples** of the world.

#### Article 44

All the rights and freedoms recognized herein are equally guaranteed to male and female indigenous individuals.

#### Article 45

Nothing in this Declaration may be construed as diminishing or extinguishing the rights **indigenous peoples** have now or may acquire in the future.

- 1. Nothing in this Declaration may be interpreted as implying for any State, people, group or person any right to engage in any activity or to perform any act contrary to the Charter of the United Nations or construed as authorizing or encouraging any action which would dismember or impair, totally or in part, the territorial integrity or political unity of sovereign and independent States.
- 2. In the exercise of the rights enunciated in the present Declaration, human rights and fundamental freedoms of all shall be respected. The exercise of the right set forth in this Declaration shall be subject only to such limitations as are determined by law and in accordance with international human rights obligations. Any such limitations shall be non-discriminatory and strictly necessary solely for the purpose of securing due recognition and respect for the rights and freedoms of others and for meeting the just and most compelling requirements of a democratic society.
- 3. The provisions set forth in this Declaration shall be interpreted in accordance with the principles of justice, democracy, respect for human rights, equality, non-discrimination, good governance and good faith.

### 18

#### Indigenous and Tribal Peoples Convention 1989 (ILO No. 169)

In 1957, the International Labour Organization (ILO) adopted the first international instrument entirely devoted to indigenous and tribal peoples' rights — the Indigenous and Tribal Populations Convention (Convention No. 107). In the 1980s, the Convention was revised and replaced in 1989 by the Indigenous and Tribal Peoples Convention (Convention No. 169).

The principles of participation and consultation are the cornerstone of Convention 169. This Convention and the UN Declaration on the **Rights of Indigenous Peoples** adopted in 2007 are mutually reinforcing instruments providing the framework for the universal protection of indigenous and tribal peoples' rights.

# Part 3 Compilation of Relevant Decisions Under the UNFCCC Process

#### 3.1 References Contained in the Paris Agreement

#### **Preamble**

Acknowledging that climate change is a common concern of humankind, Parties should, when taking action to address climate change, respect, promote and consider their respective obligations on human rights, the right to health, the **rights of indigenous peoples**, local communities, migrants, children, persons with disabilities and people in vulnerable situations and the right to development, as well as gender equality, empowerment of women and intergenerational equity,

#### **Article 7.5**

Parties acknowledge that adaptation action should follow a country-driven, gender-responsive, participatory and fully transparent approach, taking into consideration vulnerable groups, communities and ecosystems, and should be based on and guided by the best available science and, as appropriate, **traditional knowledge**, knowledge of **indigenous peoples** and local knowledge systems, with a view to integrating adaptation into relevant socioeconomic and environmental policies and actions, where appropriate.



## 3.2 Mandates and Decisions Related to the Local Communities and Indigenous Peoples Platform

#### Decision 1/CP.21:

#### Adoption of the Paris Agreement (2015)

135. Recognizes the need to strengthen knowledge, technologies, practices and efforts of local communities and **indigenous peoples** related to addressing and responding to climate change, and establishes a platform for the exchange of experiences and sharing of best practices on mitigation and adaptation in a holistic and integrated manner;

#### Report of COP 22 (2016)

165. At the 3rd meeting, at the request of two Parties, the President agreed to conduct informal consultations on the local communities and **indigenous peoples** platform referred to in decision 1/CP.21, paragraph 135.

166. At the resumed 10th meeting, the President thanked Mr. Ther for conducting informal consultations on his behalf.



167. At the same meeting, on a proposal by the President, the COP:

- (a) Agreed to adopt an incremental approach to developing the local communities and **indigenous peoples** platform with a view to ensuring its effective operationalization;
- (b) Requested the Chair of the SBSTA to initiate the process to develop the local communities and **indigenous peoples** platform, which will include convening an open multi-stakeholder dialogue on the operationalization of the platform in conjunction with SB-STA 46 and SBI 46 to be co-moderated by the Chair of the SBSTA and a representative of indigenous peoples organizations;
- (c) Invited Parties and other stakeholders to submit, by 31 March 2017 their views on the purpose, content and structure of the platform in order to inform the multistakeholder dialogue and request the secretariat to prepare a report on the dialogue, which should also draw on the submissions;
- (d) Requested the SBSTA to consider the report in conjunction with SBSTA 47 and SBI 47 under a new agenda item, "Local communities and **indigenous peoples** platform", and conclude its consideration at SBSTA 47 by forwarding recommendations for operationalization of the platform to COP 23.



168. At the same meeting, the President requested developed country Parties and other Parties and non-Party stakeholders in a position to do so to provide financial resources for operationalizing the platform, in particular to enable representatives of indigenous peoples organizations to participate in the above-mentioned dialogue.

#### Decision 2/CP.23:

Local communities and indigenous peoples platform (2017) The Conference of the Parties.

Recalling the United Nations Declaration on the **Rights of Indigenous Peoples**, decision 1/CP.21 and the Paris Agreement,

Acknowledging that Parties should, when taking action to address climate change, respect, promote and consider their respective obligations on the rights of indigenous peoples and local communities,

Emphasizing the role of local communities and indigenous peoples in achieving the targets and goals set out in the Convention, the Paris Agreement and the 2030 Agenda for Sustainable Development, and recognizing their vulnerability to climate change,

Reaffirming the need to strengthen the knowledge, technologies, practices and efforts of local communities and indigenous peoples related to addressing and responding to climate change, and the importance of the platform established for the exchange of experience and sharing of best practices related to mitigation and adaptation in a holistic and integrated manner,

- 1. Notes with appreciation the submissions from Parties, **indigenous peoples organizations** and other relevant organizations on the purpose, content and structure of the local communities and **indigenous peoples** platform (hereinafter referred to as the platform);
- 2. Acknowledges the fruitful exchange of views that took place during the open multi-stakeholder dialogue that was convened by the Chair of the Subsidiary Body for Scientific and Technological Advice and co-moderated with a representative of **indigenous peoples organizations** during the forty-sixth session of the Subsidiary Body for Scientific and Technological Advice, on 16 and 17 May 2017;
- 3. Notes with appreciation the support provided by Belgium and New Zealand for the participation of representatives of **Indigenous peoples organizations** in the multi-stakeholder dialogue referred to in paragraph 2 above;
- 4. Welcomes the report on the proposals on the operationalization of the platform based on the open multi-stakeholder dialogue referred to in paragraph 2 above and the submissions received;
- 5. Decides that the overall purposes of the platform will be to strengthen the knowledge, technologies, practices and efforts of local communities and **indigenous peoples** related to addressing and responding to climate change, to facilitate the exchange of experience and the sharing of best practices and lessons learned related to mitigation and adaptation in a holistic and integrated manner and to enhance the engagement of local communities and **indigenous peoples** in the UNFCCC process;
- 6. Also decides that the platform will perform the following functions:
- (a) Knowledge: the platform should promote the exchange of experience and best practices with a view to applying, strengthening, protecting and preserving traditional knowledge, knowledge of **indigenous peoples** and local knowledge systems, as well as technologies, practices and efforts of local communities and **indigenous peoples** related to addressing and responding to climate change, taking into ac count the free, prior and informed consent of the holders of such knowledge, innovations and practices;



- (b) Capacity for engagement: the platform should build the capacity of **indigenous peoples** and local communities to enable their engagement in the UNFCCC process and the capacity of Parties and other relevant stakeholders to engage with the platform and with local communities and indigenous peoples, including in the context of the implementation of the Paris Agreement and other climate change related processes;
- (c) Climate change policies and actions: the platform should facilitate the integration of diverse knowledge systems, practices and innovations in designing and implementing international and national actions, programmes, and policies in a manner that respects and promotes the rights and interests of local communities and **indigenous peoples**. The platform should also facilitate the undertaking of stronger and more ambitious climate action by **indigenous peoples** local communities that could contribute to the achievement of the nationally determined contributions of the Parties concerned;
- 7. Further decides to continue to work towards the full operationalization of the Platform;
- 8. Recommends that the processes under the platform, including its operationalization, take into account, inter alia, the interests and views of local communities and **indigenous peoples**, as well as the following principles proposed by **indigenous peoples organizations**: full and effective participation of **indigenous peoples**; equal status of **indigenous peoples** and Parties, including in leadership roles; self-selection of **indigenous peoples** representatives in accordance with **indigenous peoples**' own procedures; and adequate funding from the secretariat and voluntary contributions to enable the functions referred to in paragraph 6 above;
- 9. Decides that the first activity of the platform will be a multi-stake-holder workshop on implementing the functions referred to in paragraph 6 above, to be co-moderated by the Chair of the Subsidiary Body for Scientific and Technological Advice and a representative of local communities and **indigenous peoples organizations**, who will each make an equal contribution to the design of the workshop;
- 10. Requests the Subsidiary Body for Scientific and Technological Advice to consider at its forty-eighth session (April–May 2018) the further operationalization of the platform, including the establishment of a facilitative working group, which would not be a negotiating body under the Convention, and the modalities for the development of a workplan for the full implementation of the functions referred to in paragraph 6 above, with balanced representation of local communities and **indigenous peoples** and Parties, and to conclude its considerations by making recommendations to the Conference of the Parties at its twenty-fourth session (December 2018);

- 11. Takes note of the estimated budgetary implications of the activities to be undertaken by the secretariat referred to in paragraph 9 above;
- 12. Requests that the actions of the secretariat called for in this decision be undertaken subject to the availability of financial resources.

#### Decision 2/CP.24:

**Local Communities and Indigenous Peoples Platform (2018)**The Conference of the Parties,

Recalling the Charter of the United Nations and United Nations General Assembly resolution 66/288, Also recalling the Paris Agreement, decision 1/CP.21 and decision 2/CP.23,

Emphasizing that the purpose and functions of the Local Communities and **Indigenous Peoples** Platform and its Facilitative Working Group will be carried out consistent with international law.

Also emphasizing, in its entirety, the United Nations Declaration on the **Rights of Indigenous Peoples** in the context of the implementation of the functions of the Local Communities and **Indigenous Peoples** Platform involving **indigenous peoples**,

Further emphasizing that in the context of the implementation of the functions of the Local Communities and **Indigenous Peoples** Platform involving local communities, none of the activities should authorize or encourage any action, which will dismember or impair, totally or in part, the territorial integrity or political unity of sovereign and independent States,

- 1. Decides to establish the Local Communities and **Indigenous Peoples** Platform Facilitative Working Group;
- 2. Affirms that the Facilitative Working Group is established with the objective of further operationalizing the Local Communities and **Indigenous Peoples** Platform and facilitating the implementation of its functions;

- 3. Decides that the Facilitative Working Group shall comprise 14 representatives, as follows:
- One representative of a Party from each of the five United Nations regional groups;
- (b) One representative of a Party from a small island developing State;
- (c) One representative of a least developed country Party;
- (d) Seven representatives from indigenous peoples organizations, one from each of the seven United Nations indigenous sociocultural regions;
- 4. Requests the Subsidiary Body for Scientific and Technological Advice to consider, in the context of the review referred to in paragraph 27 below, and taking into account progress related to the representation of local communities, the addition of at least three additional representatives to represent local communities, as well as a process for the appointment of such representatives, and an equal number of Party representatives, with a view to recommending a draft decision on the representation of local communities on the Local Communities and Indigenous Peoples Platform for consideration and adoption by the Conference of the Parties at its twenty-seventh session (November 2021);
- 5. Decides that Party representatives shall be appointed by their respective regional groups and constituencies, and that the Chair of the Subsidiary Body for Scientific and Technological Advice shall be notified of these appointments;
- 6. Also decides that **indigenous peoples** representatives shall be appointed by the **indigenous peoples**, through their focal points, and that the Chair of the Subsidiary Body of Scientific Technological Advice shall be notified of these appointments;
- 7. Further decides that, along with each representative, one alternate may be designated, in accordance with the appointment process referred to in paragraphs 3–6 above; the alternate representative will participate in meetings when the representative is unable to attend, and will replace the representative for the remainder of the term if the representative cannot complete the functions of the assigned office;
- 8. Decides that representatives of the Facilitative Working Group shall serve for a term of three years and shall not be eligible to serve two consecutive terms, and that the representatives shall remain in office until their successors have been elected;

- 9. Also decides that the Facilitative Working Group shall elect annually two co-chairs and two vice co-chairs from among its representatives to serve for a term of one year each, with one co-chair and one vice co-chair being a representative from a Party and the other co-chair and vice co-chair being a representative from **indigenous peoples** and, as appropriate, local communities;
- 10. Further decides that the election and rotation of the co-chairs and vice co-chairs will take into account regional geographic balance, and strive for gender balance;
- 11. Decides that if one of the co-chairs is temporarily unable to fulfil the obligations of the office, the respective vice co-chair shall serve as the co-chair;
- 12. Also decides that if one of the co- chairs or vice co-chairs is unable to complete the term of office, the Facilitative Working Group shall elect a replacement to complete that term of office, in accordance with paragraphs 9 and 10 above;
- 13. Invites Parties to promote the engagement of local communities in the Local Communities and **Indigenous Peoples** Platform with a view to enhancing their participation in the Facilitative Working Group and the Platform:
- 14. Stresses the importance of striving for gender balance in the appointment processes of representatives in accordance with decisions 36/CP.7, 23/CP.18 and 3/CP.23;
- 15. Decides that the Facilitative Working Group shall operate on the basis of consensus;
- 16. Invites Parties, local communities and **indigenous peoples** to take into consideration the Local Communities and **Indigenous Peoples** Platform and its functions at the local, national and regional level in order to enhance the engagement and inclusion of **indigenous peoples** and local communities to facilitate the exchange of experience and the sharing of best practices and lessons learned on mitigation and adaptation in a holistic and integrated manner;
- 17. Decides that the Facilitative Working Group shall meet twice per year in conjunction with the sessions of the subsidiary bodies and the session of the Conference of the Parties:

18. Also decides that the Facilitative Working Group, under the incremental approach, will propose an initial two- year workplan for the period 2020–2021 for implementing the functions of the Local Communities and **Indigenous Peoples** Platform for consideration by the Subsidiary Body for Scientific and Technological Advice at its fifty-first session (December 2019);

19. Further decides that the workplan referred to in paragraph 18 above should take into account experiences from any activities that have already taken place under the Local Communities and **Indigenous**Peoples Platform, and that the workplan may include annual in-session events in conjunction with the sessions of the Conference of the Parties and the Subsidiary Body for Scientific and Technological Advice, on which summary reports, which could be of a technical nature, would be prepared by the Facilitative Working Group;

20. Encourages the Facilitative Working Group to collaborate with other bodies under and outside the Convention, as appropriate, aiming at enhancing the coherence of the actions of the Local Communities and **Indigenous Peoples** Platform under the Convention;



- 21. Requests the secretariat, with the support of the Facilitative Working Group, to make the work of the Local Communities and **Indigenous Peoples** Platform widely accessible, including through the development of a dedicated web portal on the Local Communities and **Indigenous Peoples** Platform on the UNFCCC website;
- 22. Also requests the secretariat to organize a thematic in-session workshop, in conjunction with the fiftieth session (June 2019) of the Subsidiary Body for Scientific and Technological Advice, on enhancing the participation of local communities, in addition to **indigenous peoples**, in the Local Communities and **Indigenous Peoples** Platform;
- 23. Further requests the secretariat to develop, under the incremental approach for the operationalization of the Local Communities and **Indigenous Peoples** Platform, activities related to the implementation of all three functions of the Platform,1 at each session of the Subsidiary Body for Scientific and Technological Advice until the workplan is adopted, and invites Parties, observers and other stakeholders to submit their views on possible activities via the submission portal by 28 February 2019:
- 24. Requests the Facilitative Working Group to report on its outcomes, including a draft second three-year workplan, and on the activities of the Local Communities and **Indigenous Peoples** Platform, for consideration by the Conference of the Parties at its twenty-seventh session through the Subsidiary Body for Scientific and Technological Advice at its fifty fourth session (May–June 2021);
- 25. Decides to endorse the draft work- plan referred to in paragraph 24 above at its twenty seventh session;
- 26. Requests the secretariat to make the reports referred to in paragraph 24 above publicly available on the UNFCCC website;
- 27. Decides that the Subsidiary Body for Scientific and Technological Advice will review the outcomes and activities of the Facilitative Working Group, taking into account the reports referred to in paragraph 24 above, at its fifty-fourth session and make recommendations to the Conference of the Parties at its twenty-seventh session with a view to the Conference of the Parties adopting a decision on the outcome of this review;
- 28. Also decides that the initial mandate for the Facilitative Working Group will span three years, to be extended as determined by the review referred to in paragraph 27 above;

- 29. Further decides that the meetings of the Facilitative Working Group shall be open to Parties and observers under the Convention;
- 30. Requests the secretariat to support and facilitate the work of the Facilitative Working Group;
- 31. Takes note of the estimated budgetary implications of the activities to be undertaken by the secretariat referred to in paragraph 30 above;
- 32. Requests that the actions of the secretariat called for in this decision be undertaken subject to the availability of financial resources;
- 33. Invites interested Parties and organizations to provide financial and technical support, as appropriate, for the implementation of the functions of the Local Communities and **Indigenous Peoples** Platform.

# Report of the first meeting of the Facilitative Working Group of the Local Communities and Indigenous Peoples Platform (2019)

The following summary is the official summary included in the report. The full report, including the work plan, is not reproduced here due to space constraints. It is available via the Official Document System of the United Nations under UN doc symbol FCCC/SBSTA/2019/4 and linked to in the Table of References of this report.

#### Summary

The Facilitative Working Group of the Local Communities and Indigenous Peoples Platform was established at the twenty-fourth session of the Conference of the Parties. This report provides a summary of its 1st meeting, held from 14 to 16 June 2019, in conjunction with the fiftieth sessions of the subsidiary bodies, at which a draft initial two-year workplan for implementing the functions of the Local Communities and Indigenous Peoples Platform was prepared. The report also contains organizational and procedural information, including on membership and on co-chairing and working arrangements, and a synthesis of the discussions that took place at the meeting. Discussion topics included the dedicated Local Communities and Indigenous Peoples Platform web portal, an update on activities organized by the secretariat for the fiftieth sessions of the subsidiary bodies, and enhancing the coherence of actions under the Platform. Annex I contains the proposed initial two-year workplan for 2020–2021 for operationalizing the Local Communities and Indigenous Peoples Platform for consideration by the Subsidiary Body for Scientific and Technological Advice.

- 13. Requests the Facilitative Working Group to invite Parties, **indigenous peoples** and local communities and other stakeholders to make submissions by the 10th meeting of the Facilitative Working Group (November–December 2023) on the review referred to in paragraph 12 above;
- 14. Notes with appreciation the support provided by Canada, Finland, Germany, New Zealand, the Russian Federation and Sweden for implementing the functions of the Local Communities and **Indigenous Peoples** Platform, including as part of the initial two-year workplan;
- 17. Invites interested Parties and organizations to provide financial support for implementation of the functions of the Local Communities and **Indigenous Peoples** Platform;

# Report of SBSTA 52 to 55:

Local Communities and Indigenous Peoples Platform (2021)

39. The SBSTA considered this agenda item at its 4th and 6th meetings. It had before it document FCCC/SBSTA/2021/1. At the 4th meeting, the Chair invited Thomas Cameron (FWG member representing Western European and other States) and Hindou Oumarou Ibrahim (FWG member representing the United Nations indigenous sociocultural region of Africa), Co-Chairs of the FWG of the LCIPP, to deliver a brief oral report on the work of the FWG. The SBSTA agreed that the item would be considered in informal consultations co-facilitated by Maxine Burkett (United States of America) and Mr. Fuller. At its 6th meeting, the SBSTA, having considered the second three-year workplan of the LCIPP, for 2022–2024, recommended a draft decision on this matter for consideration and adoption at COP 26.

### Report of SBSTA 60: Local Communities and Indigenous Peoples Platform (2024)

86. At its 1st meeting, the SBSTA agreed to consider this matter in informal consultations co-facilitated by Kajsa Fernström Nåtby (Sweden) and Clement Yow Mulalap (Federated States of Micronesia).

87. The SBSTA recommended a draft decision for consideration and adoption at COP 29.

#### Decision 14/CP.29:

### Local Communities and Indigenous Peoples Platform

The Conference of the Parties,

Noting the importance of ensuring the integrity of all ecosystems, including oceans, and the protection of biodiversity, recognized by some cultures as Mother Earth, and also noting the importance for some of the concept of 'climate justice', when taking action to address climate change,

Recognizing that the knowledge systems of **Indigenous Peoples** are diverse and an integral part of their identities, values, spiritualities and worldviews, and that local knowledge and value systems are also diverse and dependent on the contexts of local communities,

Recalling decision 1/CMA.5, whereby, inter alia, it was reaffirmed that sustainable and just solutions to the climate crisis must be founded on meaningful and effective social dialogue and participation of all stakeholders, including **Indigenous Peoples** and local communities, and noted that the global transition to low emissions and climate-resilient development provides opportunities and challenges for sustainable development and poverty eradication, and the implementation of integrated, multi-sectoral solutions, building on the best available science as well as **Indigenous Peoples**' knowledge and local knowledge systems was encouraged, and the role of the Local Communities and **Indigenous Peoples** Platform in strengthening the capacity of **Indigenous Peoples** and of local communities to effectively engage in the intergovernmental process under the Paris Agreement was recognized,

- 1. Welcomes the progress of the Facilitative Working Group of the Local Communities and **Indigenous Peoples** Platform in facilitating implementation of the functions of the Platform;
- 2. Also welcomes the report of the Facilitative Working Group,<sup>2</sup> including the draft workplan of the Local Communities and **Indigenous Peoples** Platform for 2025–2027 contained therein;
- 3. Decides to continue the mandate of the Facilitative Working Group;
- 4. Notes with appreciation the financial support provided, including by the Governments of Australia, Canada, Finland and Norway, for implementing the functions of the Local Communities and **Indigenous Peoples** Platform;
- 5. Expresses appreciation to the Government of Chad for hosting the biregional gathering for the Asia and Africa regions and to the Governments of Australia and Norway for hosting the regional gatherings for the Pacific and Arctic regions respectively under the workplan of the Local Communities and **Indigenous Peoples** Platform for 2022–2024;
- 6. Recognizes the important role of the Local Communities and **Indigenous Peoples** Platform and its Facilitative Working Group in bringing together Parties, **Indigenous Peoples** and local communities to work towards achieving the objective of the Convention and the goals of the Paris Agreement;

- 7. Notes the challenges and recommendations outlined in the report referred to in paragraph 2 above in relation to facilitating the enhanced engagement of **Indigenous Peoples** and of local communities under the Convention and the Paris Agreement;
- 8. Encourages Parties, **Indigenous Peoples** as well as local communities to actively engage under the Local Communities and **Indigenous Peoples** Platform, including by engaging in the meetings of the Facilitative Working Group;
- 9. Requests the secretariat to explore ways to enable members of the Facilitative Working Group, especially members serving as representatives of **Indigenous Peoples organizations**, to participate in sessions of the subsidiary bodies and the Conference of the Parties when performing specific tasks in their capacity as members of the Facilitative Working Group;
- 10. Also requests the secretariat to explore possible arrangements for simultaneous interpretation in the official languages of the United Nations that correspond to the actual language requirements of the members and contributors present at meetings of the Facilitative Working Group and in mandated events under the Local Communities and Indigenous Peoples Platform and to explore and inform the Facilitative Working Group at its meetings on options for furthering language support at such meetings and events to enable full participation therein in additional relevant languages, as appropriate;
- 11. Invites Parties that wish to do so to provide simultaneous interpretation into languages other than the official languages of the United Nations at meetings of the Facilitative Working Group and mandated events under the Local Communities and **Indigenous Peoples** Platform and requests the secretariat, where possible, to make any necessary arrangements for accommodating such additional simultaneous interpretation;
- 12. Recognizes the importance of institutional knowledge and continuity in the efforts of the Facilitative Working Group to further operationalize the Local Communities and **Indigenous Peoples** Platform and facilitate implementation of the functions of the Platform;
- 13. Decides that, of the representatives who will be appointed as members of the Facilitative Working Group with a term beginning in June 2025, three Party representatives and three representatives from **Indigenous Peoples organizations** shall serve for a term of two years instead of three years, after which time all representatives shall serve for a term of three years in accordance with decision 2/CP.24;

- 14. Invites the Facilitative Working Group to decide which Party representatives and which representatives from **Indigenous Peoples organizations** shall serve for a term of two years, as referred to in paragraph 13 above, in a manner that ensures geographical and gender balance;
- 15. Notes with appreciation that activities and mandated events under the Local Communities and **Indigenous Peoples** Platform, as well as meetings of the Facilitative Working Group, remain open to and inclusive of local communities and a wide range of Platform contributors, encourages Parties and relevant constituted bodies, in particular the Facilitative Working Group, and representatives of workstreams under the Convention and the Paris Agreement to consider ways to further engage local communities and invites the incoming Presidency of the thirtieth session of the Conference of the Parties (November 2025) to convene in conjunction with that session a thematic workshop and relevant dialogues in line with the activities included in the workplan of the Local Communities and **Indigenous Peoples** Platform;
- 16. Also invites Parties, relevant constituted bodies and representatives of work programmes under the Convention and the Paris Agreement and other stakeholders, including regional entities, to take into account the challenges and recommendations related to enhancing the engagement of **Indigenous Peoples** and of local communities under the Convention and the Paris Agreement as detailed in the report referred to in paragraph 2 above;
- 17. Requests the Facilitative Working Group to report on the outcomes of its work, including the activities under the workplan for 2025–2027, to consider and, as appropriate, propose recommendations relating to the scope and functions of the Platform and to prepare a draft workplan for the Local Communities and **Indigenous Peoples** Platform for 2028–2031 for consideration by the Conference of the Parties at its thirty-second session (November 2027) through the Subsidiary Body for Scientific and Technological Advice at its sixty-sixth session (June 2027):
- 18. Decides that the next review of the Facilitative Working Group will take place in 2027 and requests the Subsidiary Body for Scientific and Technological Advice to conduct the review at its sixty-sixth session with a view to the Conference of the Parties adopting a decision thereon at its thirty-second session;

- 19. Invites Parties, **Indigenous Peoples**, local communities and stakeholders to submit via the submission portal3 by 30 September 2026 views on activitimatic focuses for the workplan of for 2028–2031 for consideration by the Facilitative Working Group at its 16th meeting, to be held in 2026, and to submit via the submission portal by 1 November 2026 views on the impact of work under the Local Communities and **Indigenous Peoples** Platform, which will serve as input to the review of the Facilitative Working Group in 2027;
- 20. Encourages Parties, relevant constituted bodies and representatives of work programmes under the Convention and the Paris Agreement and other stakeholders to actively collaborate with the Facilitative Working Group;
- 21. Invites interested Parties and organizations to provide financial support for the implementation of the functions of the Local Communities and **Indigenous Peoples** Platform;
- 22. Requests the secretariat to continue to support and facilitate the work of the Facilitative Working Group;
- 23. Takes note of the estimated budgetary implications of the activities to be undertaken by the secretariat referred to in paragraphs 2, 10 and 11 above;
- 24. Requests that the actions of the secretariat called for in this decision be undertaken subject to the availability of financial resources.

The SBI and the SBSTA welcomed the report on the first Koronivia road map in-session workshop, on topic 2(a) (modalities for implementation of the outcomes of the five in-session workshops on issues related to agriculture and other future topics that may arise from this work), which was held in conjunction with SB
- 49. The SBSTA and the SBI considered the workshop report and agreed to:
- (d) Recognize the importance of the continued involvement of scientific and technical knowledge in transforming the agriculture sector, enabling conditions, the crucial role of farmers, youth, local communities and indigenous peoples, including gender considerations, and of meeting the needs of farmers and food systems;
- 47. The SBI and the SBSTA requested the secretariat to organize, in addition to the workshops mandated in the Koronivia road map and subject to the availability of supplementary funds, an intersessional workshop between SB 51 and 52 (June 2020) to contribute to delivering the outcomes of the KJWA, taking into consideration the vulnerabilities of agriculture to climate change and approaches to addressing food security, and to prepare a report on the workshop for consideration at SB 52. They took note of the importance of issues, including, but not limited to, farmers, gender, youth, and local communities and **indigenous peoples**. They welcomed with appreciation the offer of the Government of New Zealand to host the workshop. They requested the secretariat to take into account the following elements when organizing the workshop:
- (a) Sustainable land and water management, including integrated watershed management strategies, to ensure food security;
- (b) Strategies and modalities to scale up implementation of best practices, innovations and technologies that increase resilience and sustainable production in agricultural systems according to national circumstances.

### Arrangements for intergovernmental meetings

201. To ensure open, inclusive and meaningful observer engagement in the face of an increasing number of admitted observer organizations, while fully preserving and respecting the Party-driven nature of the UNFCCC process and ensuring alignment with the draft rules of procedure being applied, the SBI took note of the views provided by Parties and observer organizations, and highlighted the following existing and additional practices and steps for engaging observers, subject to the availability of financial resources and while increasing the participation of observer organizations from underrepresented regions:

- (a) Recommending that current and incoming COP Presidencies:
  - (ii) Continue to increase the engagement of observer organizations, particularly organizations from underrepresented regions and organizations for children and youth, **Indigenous Peoples** and women and gender, in Presidency initiatives and events;

 (ii) Consider developing capacity-building initiatives for observer organizations, particularly organizations from underrepresented regions and organizations for children and youth, Indigenous Peoples, and women and gender;

#### 15. Requests the secretariat to:

(ii) The engagement of relevant stakeholders referred to in decision 4/CMA.3, annex, paragraph 8, as well as Indigenous Peoples and local communities, including representatives of the Facilitative Working Group of the Local Communities and Indigenous Peoples Platform, for fostering the open exchange of information and articulating cooperation opportunities on specific non-market approaches proposed by interested Parties;

17. Reiterates its request to the secretariat to include as part of the broader capacity-building programme related to Article 6 of the Paris Agreement activities related to the work programme under the framework for non-market approaches, including activities to build:

- (a) The capacity for the identification, development and scaling-up of non-market approaches, including by encouraging the participation of relevant stakeholders, including **Indigenous Peoples** and local communities;
